Senior School Textiles and Design/Technology Mandatory Teacher

Purpose and Outline of Role

We seek an enthusiastic and determined teacher, able to deliver a range of TAS subjects. The successful applicant will be able to teach Stage 4 Technology Mandatory and Stage 5 Textiles Technology, in a supportive environment with a range of existing teaching and learning resources. Willingness to teach Stage 6 Textiles and Design (Year 11 only) would be advantageous, but not essential. Enthusiastic early career teachers are encouraged to apply. If you are looking to work in a highly collegial team, where training and support to develop your skills and career are provided, then we would like to hear from you.

Employment Basis

This is a part time 0.4 to 0.6FTE, temporary appointment commencing in Term 1, 2024 for a term of up to 11 months. Employment flexibility will be considered for the right applicant.

Reporting Relationships

The post-holder will report ultimately to the Principal and directly to the Head of Design and Technology.

Role Responsibilities

- Plan, prepare and deliver instructional activities that facilitate active learning
- Develop schemes of work and lesson plans
- Establish and communicate clear objectives for all learning activities
- Prepare classroom for learning activities
- Assess and manage risk for any first hand investigations undertaken as part of the practical component of the subject
- Provide a variety of learning materials and resources for use in educational activities
- Use relevant technology to support instruction
- Observe and evaluate students' performance and development
- Assign and grade examinations, assessment tasks, class work, homework, tests and assignments in a timely manner. The course coordinator will provide support and guidance during these operations.
- Provide appropriate, effective and timely feedback for formative and summative tasks completed by students
- Communicate, when necessary, information regularly to students, colleagues and parents regarding student progress and student needs
- Attend meetings, training, school functions as required and perform regular duties such as playground duty etc. Some of these may require attendance out of hours.



Key Competencies

- The capacity to deliver a range of TAS subjects, including Stage 4 Technology Mandatory, Stage 5 Textiles Technology and possibly Stage 6 Textiles and Design.
- Competence or a willingness to undertake supported training in the application of digital technologies including laser cutting, 3D printing, fabric printing including dye sublimation
- Confidence using the Adobe Creative Suite (training can be provided if necessary)
- Experience in or willingness to develop skills in Coding using the Arduino platform (applicants new to coding would be supported with a full training program and mentor teacher support)
- A deep love of design across a range of contexts, with the ability to foster in young people a love of the design and creative process.
- Ability and willingness to evaluate and critically reflect upon own professional practice
- Ability to create a positive, supportive and engaging classroom climate that meets the academic, social and emotional needs of all students

- A lively intellect with a strong interest in the life of the mind beyond the boundaries of externally imposed curricula
- Deep commitment to the welfare of young people and the ability to relate warmly and confidently with adolescents
